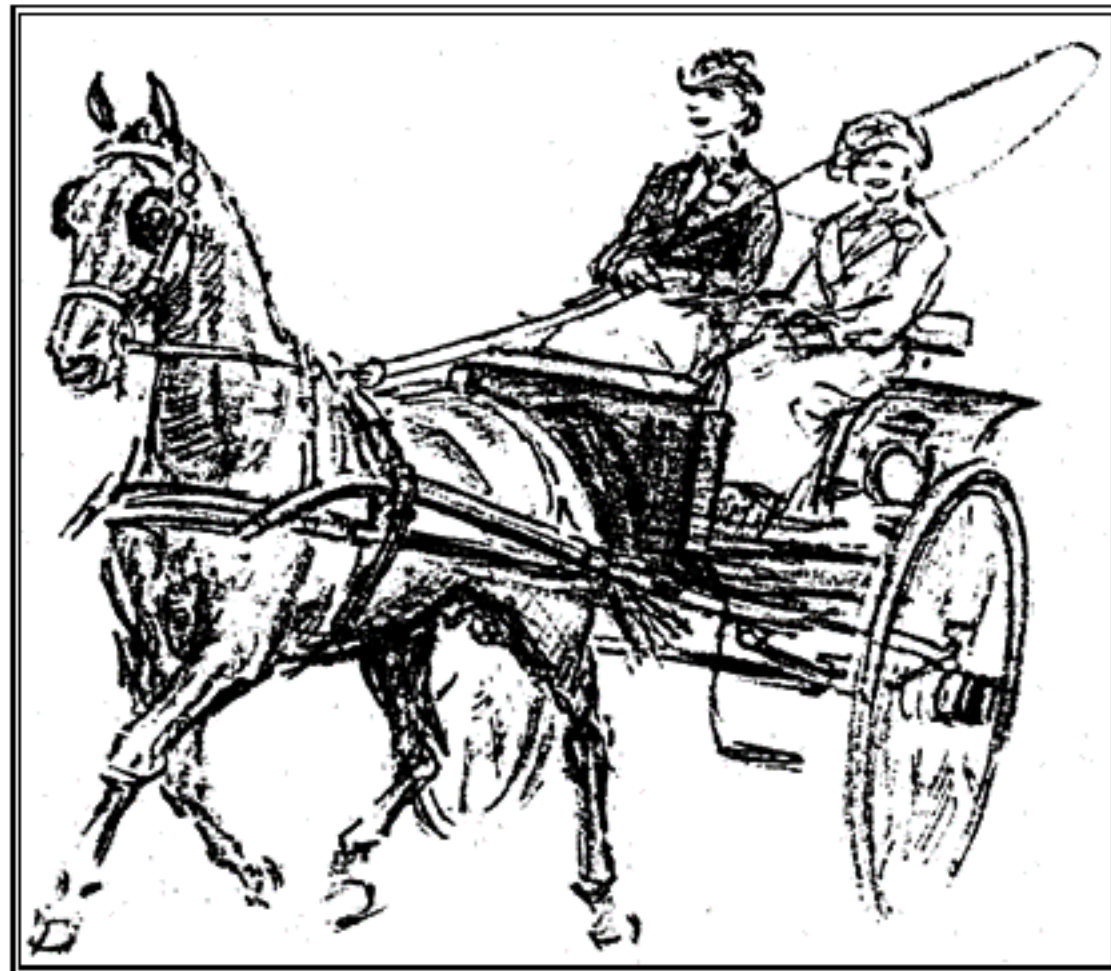

 - 6 *Intermediate:- Run at appropriate heights*
 - 7 *Novice Driver:- Run at appropriate heights NZCDS members only*
 - 8 *Training:- Open to any combination. Run at appropriate heights*
 - 9 Open Donkeys/Mules NZCDS members only
 - 10 *Training Donkey/Mules. Do not need to be a NZCDS member*
